December Board Meeting Highlights

Bookkeeper: There is currently approximately \$10,000 owing for delinquent association dues. It also is reported that a new printer has been purchased for the previous bookkeeper and will be given to her upon the return of the Cross Creek

Rec. Center: Everything is going very well, the toddler play group is off to a great start. The facility is looking more finished every weekend. The carpet is to be replaced soon and everyone is looking forward to the project being finished.

Prop Standards: Brent has sent out several letters to homeowners regarding violations and has had several Responses. The board has waived a few fines and reduced others. Brent also reports that the "pre-draft" of the covenants will be finished for review before too long. Covenants will need to be voted on before the annual meeting in April, so will need to be mailed.

All other reports are that it has been quiet in the neighborhood, no complaints.

January Board Meeting Highlights

Rec. Ctr: Everything looks great, laminate has been installed and the new carpeting has also been installed. Linda will be finishing up the kitchen tile and plan for the January potluck, hoping that all homeowner's can find their way to the Rec. Ctr for a looksee!! Nancy said she ear-marked the fundraising money so Linda can now plan on using that for the new projector and screen they had in mind for homeowners to use and begin movie night again. The question was raised about rentals: do we raise rental fees and what constitutes a rental??:

private parties - rental

scouts - open to community - yes

open to everyone-but making money - consider it a rental

There was much discussion about raising rental fees but a decision was not made. Maintenance: The tractor currently being used is three years old and has been in for repair of the transmission twice costing approx. \$500 each time. Under discussion is whether to pay for a new tractor or to keep paying for repairs. Lee estimates a new tractor would cost approximately \$3000. Discussion included a suggestion of a cost analysis of a lawn service vs tractor, payroll etc. Lee's opinion is that it is much more cost effective to keep service as it is. Lee has obtained estimates from lawn maintenance providers at \$2,000 a month for our common areas, not including trimming trees & shrubbery, debris picked up and RV lot weed control among many other items not included. suggested scheduling work parties, starting a calendar for a plan. Lee thought a good idea but on the other hand extremely difficult to plan and would rely on volunteer efforts.

Prop Stds: Brent said the attorney's will have the preliminary rough draft of covenants done soon to be presented to him, they have questions of Brent. Brent hopes to have a preliminary draft to present to the board at the Feb board meeting. A lot of work needs to be done before the annual meeting in April and we will need to have a decisive vote of homeowners.

For discussion in Feb: Do we want commercial ads in the Times?? We will be taking a vote in February and will consider a rate schedule if voted in.

Rec. Ctr rental fees - should they be raised??

Bookkeeping & Treas: Rich & Nancy gave reviews of the bookkeeping and transition to Quick Books. The state audit went well, they only reviewed the payroll. Rich gave a review of the Chart of Accounts for the Treasurer and also what quarterly reports the Treasurer will be responsible for

Rec Center: The big screen tv has arrived and is in place. Linda reports that movie nights will begin again and she is planning for summer activities. Discussion at the January board meeting included that of raising the dues for the rental of the Rec Center.

The motion was made to change the rates to the above and the motion passed. The new rates will be effective March 1,2005 for anyone making reservations after that date.

Deline HOA representatives were present and made a proposal that their homeowners, approximately 20 households be allowed to use the Cross Creek pool and facility during the summer months at a rate of \$50 per household. Their proposal would bring in \$1000 revenue to Cross Creek. After much discussion, Rich thanked them for their proposal and we would discuss at a future Board meeting.

Neigborhood Watch: Marilyn reports that she did have one call about a suspicious character riding his bike around the neighborhood while talking into a recording device. It happened to be Brent, making his property standards rounds!! The young person who reported this to his Dad is to be commended, everyone should be so aware!!

Marilyn also reports that there has been a rise in mail theft in the areas of Kinnamon and also 173rd. She would like to see homeowners replace their standard mailboxes with locking boxes as a deterrent.

March Board Meeting Highlights

Bookkeeping & Treas: Bookkeeping reports a checking account balance of \$8,360.53 and savings of \$3,276.48. She has 6 liens to file which will be done soon. There have been many expenses lately, \$3,000 to the attornies, \$1,000 which was actually Rec Center fundraising monies that were raised and lastly, \$900 in IRS penalties for taxes. New budgeting with our new treasurer will begin soon.

Congratulations are extended to Nancy Brewer who is our new Cross Creek bookkeeper. Any questions regarding your account, she is the person to call!

Rec Center: Linda absent, nothing new to report. Lee mentioned that originally when the remodel discussion began, we discussed new doors leading out to the pool area. The doors are currently on sale at Lowe's for approximately \$300, down from \$500. He also states that Linda can get the labor to install them donated so would like Board approval to go forth. The motion was made to purchase and carried with 3 yes votes and 2 nay.

Neigborhood Watch: Marilyn reports that the sherriff's office is still reporting escalating mail theft. Marilyn would also like residents to know of the new web site that lists weekly Forced Release Reports. The page lists the number of inmates that the jail must release each week due to overcrowding. The link is: http://pswebpub.co.washington.or.us/ims/ forced/

Washington Co wants teen parents to be aware of the time reference of "4:20" (four-twenty). It apparently is a "secret code" for a time to get high. If he or she is using the term while instant messaging with friends or has a 420 sticker on backpack, call them on it and make time for conversation regarding its meaning.

Maintenance: Leo proposed that with escalating mail theft perhaps we should reinstitute some type of reimbursement to homeowners for locking mailboxes again (post office approved) The cost of the stanchions supporting mailboxes is approx \$100-\$150 a set. Leo's motion is to reimburse homeowner \$150 for proof of purchase of locking mailboxes. That would also include the homeowner's doing all the work of getting the neighbors together to install the locking mailboxes and what type they use. This would also help defray the cost of Lee's labor to replace the stanchions. The motion passed and the offer will be in place until June 30,2005.

June Board Meeting Highlights

The regular monthly meeting was called to order at 7:11pm.

While we were waiting for more board members Rich read a couple of e-mails that he received from homeowners. He would like to remind all residents/homeowners who send e-mail to include their name, phone # and lot#. One letter was addressing the swimming pool and lessons. Resident was concerned that non-CrossCreek residents were allowed to take swim lessons and that we had to add additional classes for CrossCreek kids to be able to take lessons. Lee indicated he has never had to add classes and that CrossCreek residents always take precedence.

Homeowner Sherrill Frank along with Debbie Teasdale were present to make a proposal regarding the pool. They are proposing a "Snack Shack" at the pool so the kids can purchase a small snack if they are hungry. These would be nutritious snacks at a nominal fee such as: string cheese, apples or apple sauce or frozen fruit juice bars as an example. The hours would be Mon-Fri in the afternoon and possibly weekends. Since we did not have a quorum to make a decision, the proposal was put on hold until the next board meeting.

The bookkeeper reports checking acct balance of \$8,402.87 & savings balance of \$3,249.67. The annual dues statements have gone out. In the transition from Peachtree to Quick Books six transactions were lost in the shuffle. The bookkeeper and treasurer are working on resolving those issues.

Neighborhood Watch: Marilyn absent but sent word that the annual Neighborhood Night Out will be on Aug 2nd. It was decided we will participate once again. Marilyn will contact the sheriff's office to request presence at the Rec Center.

Property Standards had submitted the final draft of the CC&R's to the attorney for finalization. They will be ready for Board review probably in August.

Brent needs to have more homeowner participation in Property Standards for two reasons: We need to have walkers go throughout the neighborhood to help with violations and 2nd to help with proposing changes to the CC&R's in the future. Keeping abreast of what problems are encountered and changes that will need to be made in the future and presented at the annual meeting are all functions of being involved in your community. A motion was also made to charge \$10 per month rent for a space in the RV lot, being billed quarterly. Rich asked that the motion be tabled until the July board meeting when we have more members present.

July Board Meeting Highlights

The regular monthly meeting was called to order at 7:05pm.



First on the agenda was a discussion surrounding a proposal to have a Snack Shack at the Rec Ctr. The Snack Shack would be attended by adult homeowners who have teaching backgrounds. Their proposed menu included items such as bottled water or juice, cheese & crackers, string cheese, otter pops etc.

After much discussion, including the voice of the lifeguards and input from homeowners who voiced their concern, votes were taken. The majority of homeowners agreed to give the Snack Shack a try and board members agreed to give it a try for the remainder of the season.

Neighborhood Watch: Marilyn proposed that the National Night Out that we participate in every year would be a great time to have a neighborhood bar-b-que. Marilyn will be organizing this year's event and encourages all homeowners & residents to join in a bar-be-que provided by the Homeowner's Association. She would appreciate help in organizing, cooking and clean-up. If you can spare some time and energy please give her a call 503-649-4116. The sheriff's office has already called to see if they can attend, a really good sign!!

While Marilyn reports that all has been quiet in our neighborhood Deline Association has had a couple of car break-ins and theft in their area. We all need to remember not to leave valuables in our cars and to keep doors & windows locked in our homes.

Maintenance: Leo wanted to discuss mailboxes, the fact that we had proposed to allow homeowners \$150 to help pay for locking mailboxes through July of this summer. The proposal was an incentive to homeowners to install locking mailboxes but also to help defray the cost of putting in new stanchions in many of the cul-de-sacs. No one came forward to take advantage of this help. Lee will need to replace approximately 3-5 sets of stanchions this summer at a cost of up to \$1500. Carolyn made a proposal that Lee will survey the worst of the stanchions and give a list of the areas to board members. They will then go to speak to homeowners in those areas to see if they can be persuaded to install locking mailboxes instead.

We also have noticed more individual mailboxes being installed in front of homes. These do require approval from Property Standards as well as from the postal service. These installations are subject to being fined if installed without prior approval from Property Standards.

Lee will be spreading bark-dust in some of the areas as well as cedar chips around the swings and big toys that need it. The board approved expenditure will provide a measure of safety around the toys and bark dust helps with neighborhood beautification.

Property Standards: Brent needs help with Property Standards meetings and folks who are willing to walk an area of the neighborhood and spotting violations. This is an invaluable volunteer contribution to our neighborhood. He also needs homeowners to attend the monthly Property Standards meetings.



The proposal was for \$10 a month for each space, approximately 50 spaces would yield approximately \$3600 a year in revenue. The final decision is to charge \$10 per month to be billed on an annual basis with the option to pay quarterly, effective Dec 1,2005.

Mailboxes: In an effort to encourage the installation of locking mailboxes, the offer of a rebate of \$150 toward locking mailboxes is being extended through the month of September this year. Any questions, give any Board member a call.

Highlights from Board Meeting of September 08, 2005

Old Business:Locking mailboxes, rebate will be discontinued at the end of the month. Various ideas were discussed to encourage homeowners/residents to install locking mailboxes. 

IMPORTANT LETTER TO ALL CROSS CREEK HOMEOWNER'S

Re: Voting on CC&R's

In September a ballot was mailed to all homeowner's. We asked that the ballots be returned by October 13. As of November 27 we have received 77 out of 309.

The voting addresses:

- 1. All updates and amendments of CCHOA covenants are registered at the Washington County Courthouse. This condenses the past four documents into one current document.
- 2. Covers all required Oregon HOA regulations.
- 3. Approves CC Homeowners' request to:
 - A. Accept gravel on side of driveway for extra vehicle.
 - B. Prohibit parking of large commercial vehicles in the association.
- 4. Adds clarifications of some sections. Moves verbiage from the By-laws to the CC&R's.

Based on CC homeowners' requests, the Board instructed the subcommittee to check with several area law firms. The law firm selected by the Board specializes in Oregon homeowner associations. This insures that CCHOA is in compliance with all applicable Oregon statues.

Also, our CCHOA CC&R's will be registered at Washington County Courthouse. This enhances the current CCHO property values, and especially, when a CC homeowner wants to list their property, their realtor will look here.

Legal fees\$3800.00Printing Costs\$521.60

Office Costs (Envelopes, labels, etc) \$117.42

Mailing Costs \$420.00

Total Cost \$4859.02

When CC homeowners' vote yes, it means they want the CCHOA Declaration to show that we are in compliance with all applicable Oregon statutes, the CCHOA CC&Rs to be registered with Washington County Courthouse under one document that can easily be found, and the \$5,000.00 was properly spent.

When CC homeowners' vote no, (or does not vote) it means they don't want the CCHOA declaration to be updated, they don't want the updated CCHOA CC&Rs to be registered with Washington Co Courthouse, and the \$5000.00 was improperly spent.

Not passing this new CC&R's does NOT:

Abolish the Association

Void the current CC&R's (including previously approved changes)
