Property Standards Reminders

Spring is when we start all those projects around the house. Remember that any structural changes to a house must be approved by the property standards committee prior to any work being done. Forms can be obtained either on the CCHOA website or at the Rec Center.

Structural changes include: changing the color of finish of the outside of your house; installing, removing or moving your fence or hedge fence; installing a yard shed, gazebo or other structure that can be seen from a neighbor's yard or from a public area.

If your fence is adjacent to a street, sidewalk or curb, you are responsible for maintaining the area between them. This includes mowing, weeding, applying bark dust or however else you would like to landscape it. Au Naturale is <u>NOT</u> acceptable. Please keep the area from becoming an eyesore.

RV's & boats are allowed to be parked at your residence for 48 hours for cleaning and preparation. Permits are available for up to two weeks. Forms are available online or at the Rec Center.

Remember not to block streets, driveways or paths to minimize it being a traffic hazard.

There has been lots of tree cutting this spring. If your tree is in good condition and within 8 feet of the curb you must contact the property standards committee before deciding to cut the tree down.
