Meeting of Jan 08, 2009

The minutes for December were approved as written, with the exception of the checking balance in the Treasurer's report; balance should have been recorded as \$3,799.36. The December minutes were amended.

Homeowner Comments: Rosa Park's Condo Association members were present to comment about a fence that is adjacent to the greenway spaces. Someone else had received a comment about the improved access ramps that the county did work on; homeowner wanted to know why their area was left out and why the association didn't include them in the improvements. This was a county project/improvement that the association was not aware of and in which they have no say.

Old Business. Three proposals for the Rec Center as well as the partition wall are still being worked on.

Job descriptions: work in progress

Discussion of the signs at the entrances to Cross Creek continue as to how to straighten and obtaining bids for work.

Calendar on the website is now working.

New: Rich presented the final accounting asked for re the tennis courts resurfacing projects. The total expended for both courts was \$37,635.33.

The Board would like to discuss the priority list that was created at the time of the Special Assessment vote. Our next meeting in February, we'll be discussing that list and would like to invite all homeowners to attend and give their input as to which improvement they would like to see next.

Property Standards: There was much discussion over property standards and the guidelines that the committee is attempting to enforce. Homeowners also need to understand that County codes were also written into our CCHOA guidelines. Please also remember the guidelines are there for everyone to follow, so that everyone can enjoy a beautiful neighborhood.

The minutes for January were approved as written,

Homeowner Comments: We heard comments from homeowners commenting about the noise of vehicles in the area. There have been complaints of noisy vehicles and gunning engines. We talked about sending complaints to Washington County due to county code violations.

Old Business. Three proposals for the Rec Center as well as the partition wall are still being worked on. John will be obtaining bids for work on dry rot on the west side of the Rec. Center. Once the bids are in, we'll have to determine whether this repair will be in the budget for next year or when it will be able to be done.

Job descriptions: work in progress

Much of the meeting was spent in reviewing a letter from attorney re a specific complaint and the results of such. Secondly that the documentation that combined all four documents of the CC&R's were combined into one. The attorney also reports that the CC&R's were not approved by 75% of homeowners in 2007.

Discussion of the list of capital improvements and how to prioritize them was tabled until March.

New: None.

Neighborhood Watch: Marilyn states she now has evenings available and would like to schedule some type of speaker from Washington County that would interest and be helpful to all residents.

Treasurer: Rich and Don will be reviewing all accounts to be sure the reserves are on track.

Property Standards: There seems to be a trend of more renters in our community so property standards will have to figure out how to address. We do not have all names of renters, sometimes only the out of area homeowner.

Homeowner Comments: We heard comments from homeowners commenting about the definition of "holiday lights" as opposed to "landscaping lights". Cheryl wants to see all quotes and bids in for the Rec Center NW wall, which needs repair due to dry rot, in place by the next regular monthly meeting in April. She also would like to see what can be done with \$2000 per bathroom, for a remodel of each bathroom. John will be working on that.

Bill reports that he did receive a bid about straightening the sign at the 209th entrance but it was cost prohibitive.

New: None.

Neighborhood Watch: Marilyn told us that Washington County has programs for kids that she is looking into. She will look at trying to schedule a safety class for kids in the near future. She was also asked to schedule a speed trailer for in our neighborhood.

Treasurer: Checking account balance is \$4,818.02; savings balance is \$31,770.26 (int \$37.00) and Special Assessment Balance \$33,230.47 (int \$34.31) A transfer of funds in the amount of \$4,000 to checking occurred.

Property Standards: Don is hoping to have a meeting with attorney to clarify Property Standards violations.



CC&R's that were filed with Washington Co have been rescinded and new combination is being completed by attorney.

There are a few that still owe special assessment and there are a few that have gone to the Cash Flow Enhancement Program. On April 30th at 7:00 the budget meeting will be held at the Rec Center. Anyone can attend.

There will be enough data gathered that can be generated into a report to be sent to us re amount of traffic and speed. The census will take place in the year 2010 however, they are now canvassing to make sure they have all addresses etc. All workers will have ID.

Meeting of May 14, 2009

The regular monthly meeting was called to order by Cheryl Wrzesinski.

The minutes for April 9 were read and approved as written. The minutes for the annual meeting of April 16 were read and approved as written.

Homeowner Comments: none

Board positions; All positions will remain the same except for the Rec Center which will be managed by David Estrada and Maintenance which will be John Kokinos.

Old Business: CC&R's are not yet completed by the attorney John still needs to work out painting details with the contractor for the siding repairs of the Rec. Center. Absent from the meeting, he will need to report later. Pam spoke with the sign maker for the entrances to our development and he let her know he will not be able to paint our signs as requested but will make and hang the smaller HOA signs for below.
