Property Standards: Discussed areas in the community with vines covering the sidewalks, boats in driveways, and fences falling over. The board agreed to move forward with violation letters with extended timeframes specifically for fence repair due to expense of replacing.

Maintenance: Garbage disposal is fully functional and the Private Property signs have been installed

Unfinished Business:

Discussed installing the pool safety and rules sign. Jim and Ted volunteered to research and install a sign and Jason agreed to paint, if needed.

New Business:

Discussed the RV Lot annual billing. Kelly made a motion that the RV Lot annual fee be non-refundable, Jim seconded the motion. The motion was called to vote, and it passed unanimously.

Annual meeting is scheduled for 4/19/2018 with the regular monthly meeting being on 4/12/2018. As a result, the budget will need to be approved in the February meeting. Items to be considered for budget are hanging fans in the rec center, replacing broken chairs and outside furniture with commercial grade.

Discussed homeowners use of the rec center. The rule was discussed and clarified that a home owner can rent the rec center free of charge if the event is open to the community.

Discussed National Night Out successes in 2017 and the amount of food and supplies needed for 2018 to ensure continued growth and success. The National Night out is August 7th, 2018.

Kelly motioned, Ted seconded to adjourn. Unanimously passed. Meeting adjourned at 8:34pm.
