# **Banking:**

## **Rec. Center:**

Nothing new to report. Suzi requested the BOD look into a 'code lock' for the Rec. Center as a way to help mitigate the recent Rec. Center doors being left open.

# Maintenance (Vacant position)

A&J sent a bill for the clean out of the 'No-Man's Land' area, which is higher than first stated. The BOD will chat with Steve Keller who is currently chairing the maintenance position, to gain clarity on this situation.

Breaker in Circuit 16 keeps tripping. Lights upstairs currently are not working. This situation may need to be checked out to ascertain the specific problem.

## **Unfinished Business:**

New common area trees have come in under budget. Ted Smyth has completed and installed two new park benches for our common areas. The RV wait List is now on line in the CCHOA website. Refresh Pool Committee needs more information on the pool. Jason will meet with a pool representative to gather more information. The committee will then determine next steps and estimates of the cost.

## **New Business:**

The budget for next year needs to be developed. This will require more information on the pool refresh project. Resurfacing of the asphalt trails will also need a bid to be included in next years' budget. The BOD may also want to include some ceiling fans for the Rec. Center in next years' budget as well.

A request was made for some cameras for the inside of the Rec. Center to better ensure security. An amount not to succeed \$500.00 was approved for this project.
