Damaged mailbox on 205th to be replaced by Ted and Windi.

We need to send fines every month to people in violation.

Tim Sautter (community member who works for Dept of Transportation for WA County) Spoke about the issue.

- Most of the issue we are seeing are coming from the discharge point on the condo's side.
- There are organizations that help with issues like ours Clean Water Services Conservation District. These organizations also offer grants Tim has offered to help us in the application process for the grants.
