Unfinished Business:

Pool Refresh

• We confirmed that our down payment check cleared with the pool company.

We need to approve budget - Maria is absent.

Properties in fine mode: we need to ensure that fines are being enforced for properties that are in violation.

• Property standards need to inform the Treasurer and the board of properties in fine mode each month, then the treasurer needs to send out fines (fined for each violation)

New Business:

Resident in violation (with 2 sheds in the backyard and door in the garage) were reported to the county, we haven't heard back from the county regarding this issue. They have multiple projects not approved and need to go into fine mode. We may need to contact our lawyer to see what our rights as an HOA are since they keep doing projects without approval.

Rec Center rental for community events:

Resident wants to rent Rec Center for a yoga class - charging \$10 per person - does this qualify as a free community event rental? The board says no. We will review these on a case by case basis.

- Community events should be free to residents
- If the homeowner is making a profit, they have to pay for the rental.

Landscapers rate will go up to \$1685 - will approve if this includes leaf clean up.
