
Cross Creek Swim Team

RECREATIONAL VEHICLE PERMITS AT THE REC CENTER

Summer is upon us and we all know that means the great outdoors and camping. It's great to hop in the RV and get away from it all, but it's important to remember that Cross Creek covenants specifically keeping restrict your RV in your driveway or on the street for any length of time.

When you're getting ready for a trip or cleaning out after a trip, it's acceptable to keep your RV in your driveway (not on the street) for up to 48 hours.



In the case of special circumstances, permits are available which allow you to keep your RV in your driveway for up to two weeks without danger of receiving a citation from Property Standards.

Permits can be obtained from the Rec Center. Please get these filled in and back to the Rec Center before you park your RV in your driveway for any extended period of time.

Homeowner Alert!!

In the past six months, the Cross Creek Community has experienced two very serious fires. These fires both were caused in dryers, located in the homes' garages.

Commonly fires occur in the lint trap or by lint which had filtered into the dryer and been set ablaze by the heating element. In the most recent incident of a dryer fire in Cross Creek, the fire began in the electrical panel in the rear of the dryer.

Both recent fires occurred while the homeowners were present in the home. Both were not alerted to the fire in time to effectively react because the garages where the dryers were located were not equipped with smoke detectors.

Another fire occurred in a dryer in Cross Creek on December 23rd (during the snowy weather) after several loads of clothes had been dried in a very short time, caused by lint on the heating element. You never heard about this fire because it was extinguished by the homeowner, alerted by a smoke detector, and caused no damage outside of the dryer itself.

The moral of this story: **Smoke Detectors**. Inside, In the Garage, Upstairs, Downstairs. Inexpensive protection and they really work!!!! (Also — make sure your dryer is well maintained and kept free of lint.)

Keep Your Street Clear!

As fall approaches and the leaves gently drift from the trees, we all need to keep in mind that it is Street Sweeping time! We will try to get a schedule for when the street sweepers plan to visit the Cross Creek neighborhood published in the next "Times" but until then, we need to take some simple steps to insure our streets and drains keep well maintained.

The most common problem encountered by the street sweeping vehicles is maneuvering around obstacles left in the street and near the curbs. It is contrary to the provisions in the Covenants to leave basketball hoops or other obstacles in the street. If you do so, you can expect a notice and become subject to a fine for failure to remedy the situation. Let's just avoid the whole process by keeping your toys within the boundaries of your own property (and out of sight).

It is also becoming a more common situation to have parked cars left on the street on an ongoing basis. Please keep your vehicle in your garage and/or driveway. It allows the street sweepers through and also makes the neighborhood more attractive for everyone.

With a little preparation we can weather the fall with a minimum of difficulty. Please be considerate of your neighbors and keep your street clear for the Street Sweepers!

CAIG Still Fighting For Responsible Growth

Citizens Against Irresponsible Growth (CAIG) are reluctant warriors fighting plans to add another 20,000 residents into a small area just west of Cross Creek. There are preliminary discussions to expand the Urban Growth Boundary to include the South Hillsboro Urban Reserve, an area of about 1,600 acres between 234th and 209th, south of TV Highway. There is concern that the Hillsboro Planning Department which is indicating its support for the expansion is not sufficiently concerned about increases in traffic and the necessity of building new sewer and water lines to accommodate the expanded population base. The possibility exists that current city residents will be forced to foot the cost of expanding infrastructure to meets the needs of the anticipated population increase. Property Standards Update

You may have noticed an increase in the number of letters being sent out in response to Property Standards complaints. You may have even received such a notice even though you are maintaining your property just as you have been in the past...

First, there has been a significant increase in the vigilance of the Property Standards team. In the past, commitment to maintaining Property Standards has been on-again, off-again. This is no longer the case — until everyone is in compliance with the Cross Creek Covenants, and the Board interpretation of those Covenants, the letters and fines will continue.

The Board is taking a stronger stance on this issue because, with increased growth in Washington County, we all have a responsibility to assist in keeping our community property values strong. In addition, the livability and enjoyment we derive from our community is dependent upon maintaining the cleanliness and beauty of our neighborhood.

Be aware that there is no "retaliatory" nature to these notices. The Property Standards team attempts to ensure this is not the case and is more than happy to work with you to resolve any issues. There are also random "drive throughs" of the entire community on a monthly basis to record violations so it's entirely possible that the problem was spotted by a Board Member or Property Standards personnel.

The violations which are most often seen are as follows:

- RVs, boats, utility trailers and/or campers parked in driveways, streets, or side yards.
- Debris and rubbish in yards.
- Unregistered vehicles these are not allowed in the street <u>or</u> driveway, only in the garage.
- Basketball hoops left in the street.
- Trees overhanging the street and preventing sweeper access.
- Fences in disrepair.

We have not yet begun notices for garbage containers, but trash receptacles are not allowed in front or side yards — in the garage or back yard is acceptable. Please keep your garbage cans out of sight and avoid receiving a notice from the Association about a violation.

Step back and take a critical look at your property. If you see a potential violation, please correct it before we have to point it out. Just because you've "always" done something a certain way does not mean it is in compliance with the Covenants.

And, remember, this benefits ALL of us. Home values as well as pride of community is the result of adhering to a strong system of Property Standards!
