Minutes from Nov. 8, 2012

Board Members present: Pam, Christy, Denise, Kelli, Don, Joann (quorum) Staff Members present: Lee, Pat,

Minutes for October were read and approved as written.

Treas rpt: Checking balance \$1,460.00 Money Market bal \$23,714.90 and Reserves acct has a balance of \$80,879.74. Approximately \$31,592 is the amount accumulated past due amounts. Per Don, our CC&R's state that the association can charge 6% interest on the past due amounts.

Maintenance: Lee announced the expenditure of \$200 for a new lawnmower. He also would like to purchase new tires for the tractor. The estimates he has received are approx \$255 per tire. Pam offered to call around for estimates and asked him to wait to make the purchase.

Don has started working on an "asset management plan" or Maintenance Study and distributed a spread sheet with different headings. Rich, Cheryl and Lee will be helping with the study as well as contributions from other board members.

Liens were discussed for homes over \$400 past due and what legalities needed to be followed. Denise will head up a committee to research liens, sending payment plan letters and formulate a plan. Don and Kelli will be committee members.

Minutes for November were read and approved as written No PIP's were presented.

Pres & VP report: Pam reported that a list of questions have been compiled for the HOA attorney. They also have a list of questions and answers re insurance but want to speak with attorney before releasing any information since there is a conflict of interest.

Treasurer report: Checking bal: \$399.88 Reserves bal: \$80,879.74 and Money Market bal: \$21,714.00. Don mentioned that most past due accounts need to have the \$25 past due fee added as has been done in the past. He also indicated that prior to 2008, HOA had charged interest on past due accounts.

Rec Ctr: Reports \$200 taken in in rental fees.

Minutes from January 10, 2013

Board Members present: Tom, Joann, Christy, Denise (quorum)

Board Members absent: Don, Kelli Staff Members present: Lee, Pat Staff Members absent: Vivian

Minutes for December were read and approved as written.

Pres & VP reports: Tom has reconsidered the necessity of meeting with the HOA attorney and has decided that it is not necessary at this time. The board members agreed.

Treas rpt: Checking balance \$3,974.98 Money Market bal \$15,714.90 and Reserves acct has a balance of \$80,879.74. Quarterly's have been filed for the fourth quarter and SAIF file reviewed. HOA dues will be mailed by February 15.

Maintenance: Lee said he is still working on cleaning up leaves. He still needs two new tractor tires, we may have another resource, asked him to wait another month for another report.

Old Business: Taxes; Vivian talked again with IRS regarding fines from 2009, and is to have an answer by February 10.

Liens: Denise brought in the original letter and a few changes have been made from suggestions at the last meeting. Denise wanted to know if the Board agreed with removing fines as part of the plan moving forward to be an incentive to pay dues. If no response to the letter sent, then fines would not be eliminated. The discussion was tabled until February when more board members present and allows more time for research of late fees and fines. Liens will be discussed more thoroughly in March and there are about 4 that need to be moved on.

New Business: We will need a new way to handle Early Bird Keys for summer swim season and a form for that purpose needs to be created. Lee indicated he already had one, but he couldn't find it. A process and a form will need to be created, will be mentioned to Kelli since she is in charge of the pool.

Tom announced the resignation of Pam. He also recommended Denise for the position until the annual meeting. Denise declined for personal reasons and Tom will take over the presidency until the annual meeting. Tom and Christy will go to the bank in the coming week to remove Pam as a signer of checks and Tom's name will be added.

We will need a volunteer to step in until elections in April Pat will put a blurb in the Times.

Financials

We've had some questions of late about the financial balances listed in the minutes so a brief explanation may be in order.

The checking account is what we pay the bills out of and people notice that fluctuation. Also noticed is the transfer of funds into that account. Our money market account is actually what is used as our "operations account". It pays a very slight amount of interest however, we can only write 5 checks per month from that account so funds are transferred into the checking account to pay the bills.

Lastly is the reserves account. This account is required by law and is to pay for any large maintenance issues or replacement of loss of property owned by the HOA. For example there was some unexpected pool repair last summer and the decision was made to pay for that out of the reserves fund.

Property Standards

Spring has sprung!! Our walkers have noted a lot of yards look beautiful already! A lot of TLC is still needed, so please start the mowing and trimming efforts.

Also we noticed there are a lot of homes that do not have house numbers. Please keep in mind this is a safety issue. If an emergency crew should need to find your home, it may be difficult.

PIP Reminder

If you are painting, planning a remodel or installing a shed, please remember to fill out a Property Improvement Proposal and bring to the next board meeting. If you can't make it, email it to Property Standards or drop it in the mail slot at the Rec Ctr. They are typically reviewed at each board meeting, at the beginning of the meeting. Remember it must be approved before your work begins.







Rec Ctr, rentals yielded \$320.00 for deposit

RV Lot: Two spaces are vacant and Denise has contacted those next on the waiting list, checking sizes of vehicles before moving in.

Maintenance: Power washer has been purchased. The power washer borrowed from a homeowner last year has been repaired and returned. The oven was checked out an repaired. Lee was asked to check out the wetlands fence, appears to be in need of repair and the weeds treated.

ASSOCIATION BOARD NOTES

Board Meeting Minutes for November, 2013

Board present: Don, Monique, Wendy, Cheryl, Jayne, Denise (quorum) Meeting was called to order by Pres. Don Duncan. Minutes were read and approved as written.

Pres Rpt: Don reports signing checks, contract for landscape maintenance & a few letters for outstanding property standards issues as part of his monthly report. He also reports keeping up with pool chemical and water levels, minor building maintenance & inspection of walking bridge.

VP Report: Monique will step in and chair property standards and reports having finished job descriptions for Pres, VP, Treasurer and bookkeeper. She will begin the Secretary/Times editor descriptions next.

Treasurer: Checking balance: \$6,606.14, Money Market; \$22,546.24 Reserve fund: \$53,047.92. Attended meetings with Finance Committee and Executive committees.

Maintenance: Motion was made to add \$1,000 to the already approved motion to hire a company for a Reserve Study. The additional \$1,000 will allow a maintenance study to be done at the same time. The total approved amount is \$4,000.

New Business: Resolution was presented with motions made re the Homeowner dues. Motion was made that the assessments be levied June 1st of each year & due on July 15 with accounts being past due on Nov. 16 of each year. A letter rescinding all other resolutions regarding due dates was also presented. Motion was seconded & passed unanimously.

Board Meeting Minutes for December 12,2013

Board members present: Don, Wendy, Denise. Monique, Jayne (quorum) Board members absent: Cheryl

Pres Rpt: Don reported meeting with various committees, including the Maintenance chair, Finance Committee, Executive Committee, met with CPA & treasurer and normal signing of checks. Don also kept up with normal maintenance activity such as pool water quality and pump operations, leaf pickup from pool cover & deck, bulb replacement & light switch cover replacement.

Property Standards: Monique reported on goals to reach new process, the need to contact Vial Fotheringham about new requirements for letters and process, reviewing documentation and regulations.

Maintenance: RFQ's have been sent out to five landscape companies and three have come out to look at properties. Cheryl still is trying to schedule Reserve study.

Unfinished business: The bookkeeper position will be offered to Nancy Brewer. Jan Miller will continue to work for board until the end of the year.

Resolution regarding assessments was discussed further and amended to: "Annual assessments will be levied each year on July 1st and due on Nov. 15. Accounts will be declared delinquent" on Nov 16 of each year. The resolution goes on to state the consequences of late payment and steps that will be taken to collect the dues. Motion was made and seconded to accept, passed unanimously. Resolution to Rescind other resolutions, dated 5/11/2007, 1/15/2010, and 4/18/2011 clarifies further that the resolutions are superseded by the current resolution. Motion was made, seconded & passed unanimously. All will be sent to homeowners once filed with the county.
